First Pacific Advisors, LP, (the "Adviser") has contractually agreed to limit Total Annual Fund Operating Expenses (excluding any front-end or contingent deferred loads, brokerage fees and commissions, acquired fund fees and expenses, borrowing costs (such as interest and dividend expense on securities sold short), taxes, and extraordinary expenses, such as litigation expenses (which may include indemnification of Fund officers and Trustees, contractual indemnification of Fund service providers (other than the Adviser))), to 0.49% of the Fund's average daily net assets for the period ended December 31, 2022, and 0.59% for each of the subsequent one-year periods ended December 31, 2023 and December 31, 2024. The Adviser may recoup any operating expenses in excess of these limits from the Fund within three years if such recoupment can be achieved within the lesser of the foregoing expense limits or the expense limits in place at the time of recoupment. This agreement may be terminated only by the Board of Trustees on 60 days' written notice to the Adviser.

Dear Shareholders:

Overview

The FPA Global Equity ETF (“Fund” or “FPAG”) declined 8.26%, net, for the quarter and declined 24.92%, net, since the Fund’s inception on December 16, 2021.

Netflix’s (NFLX; 1.2% of net assets as of 9/30/2022) shares recovered this past quarter, due in part, we believe, to investors taking an optimistic view with respect to the potential for future subscriber growth and the upcoming introduction of a lower cost, ad-supported tier. **Comcast** (CMCSA; 4.4% of net assets as of 9/30/2022) and

Charter (CHTR; 2.5% of net assets as of 9/30/2022) were discussed at length in our second quarter commentary and continue to be leading detractors for both the quarter and since inception.⁴

Looking at longer-term performance, **Glencore** (GLEN LN; 3.5% of net assets as of 9/30/2022) continued its positive performance as we believe the company operates in a genuinely shareholder-oriented manner.

The share prices of both **Meta** (META; 2.7% of net assets as of 9/30/2022) and **Alphabet** (GOOGL and GOOG; 4.8% and 3.7%, respectively, of net assets as of 9/30/2022) have declined significantly over the past twelve months. We believe this is due to a combination of a weakening ad market, depreciation of foreign currencies, and increased competitive intensity. On the positive side, we anticipate each company to continue to generate significant amounts of free cashflow even during these challenging times, which we expect to be redeployed into a combination of growth projects and share buybacks.

Portfolio profile⁵

There were 44 equity positions in the Fund, with the top 5 holdings comprising 26.9% and the top 10 comprising 45.2% of the total portfolio as of September 30, 2022. The Fund's top three sectors, based on GICS sector classification, were Communication Services (22.2%), Financials (17.0%), and Information Technology (14.3%). The portfolio has been able to find opportunity outside of the US and currently has 39.8% non-US exposure and 60.1% exposure in the US.⁶

Closing

Individual stock price movement continues to generally be far greater than changes in underlying business fundamentals. We maintain focus on the latter, while seeking to take advantage of the former.
